## CNMA 5-STAR AWARD CRITERIA for 2024 - 2025

To achieve the 5-Star Award, a lodge must amass <u>85</u> out of a possible <u>97</u> <u>POINTS</u>. The program runs May1st through April 30th.

- \*Transmitting at least one "New" or "Re-Enroll" application in any month will result in the awarding of <u>2 POINTS</u>. Maximum award: <u>24 POINTS</u>
- \*Endowment donations are sent to Moose Charities after being collected at all Lodge meetings & gatherings. For every month that this is completed on time, your lodge will receive <u>2 POINTS</u>. Maximum award: <u>24 POINTS</u>
- \*Lodge President and Administrator attendance at District Meetings. In accordance with the California Nevada Moose Association (*CNMA*) Policy Manual, Policy 1.2, <u>both</u> the Lodge President and Administrator should make every effort throughout the year to attend <u>100%</u> of all district meetings. Points will be awarded for the President and Administrator based on the standard meeting schedule for each district (i.e., monthly = one point each, bi-monthly = two points each, or quarterly = three points each). (The awarding of these points may be evaluated on a case by case basis by the CNMA Executive Committee based on a written request sent to the CNMA Vice President). Maximum award: <u>24 POINTS.</u>
- \*Moose of the Year. Entering the selectee into LCL Web by the required due date of **JULY 7**<sup>th</sup> earns **10 POINTS**.
- \*Lodge President or Administrator attends the Association Conference in March earns <u>5</u> <u>POINTS</u>. <u>Alternates will not be accepted.</u>
- \*Lodge President or Administrator attends the Association Convention in September earns <u>5 POINTS</u>. Alternates will not be accepted.
- \*Submission of a CNMA Achievement Award nominee using the <u>CNMA Achievement Award form</u> by the required due date of <u>August 14th</u> earns <u>5 POINTS.</u>

\*\*Bonus points <u>may</u> be awarded for the Association President's Project (**PP**). Minimum donation is <u>\$100</u>. This is at the discretion of the CNMA Executive Committee. Maximum award *5 POINTS*.

- \*\*Bonus points <u>may</u> be awarded for donations of the fully funded amount <u>(\$350</u>) expected by each unit to be made to the <u>A</u>lways <u>A</u>ctive <u>A</u>t Moosehaven (AAA) Project. This is at the discretion of the CNMA Executive Committee. Maximum award *5 POINTS*.
- \*\*Lodges that are delinquent in their payment of association dues (or have not made satisfactory payment arrangements) **ARE DISQUALIFIED**!
- \*\*Lodges that are delinquent in their payments to Moose International (or have not made satisfactory payment arrangements) **ARE DISQUALIFIED**!
- \*\*Appeals must be submitted for consideration by the CNMA Executive Committee within fourteen (14) days of issuance of the final results.
